Born in India, educated in the Los Angeles area, Neeti is a cosmopolitan, sophisticated Californian who tools between home and office in her sapphire-blue Jaguar.

Other entertainment was provided by several groups: CTC Entertainment, Mr. Vivek, aka "Brainstorm," who acted as the MC and performed a hip-hop/Indian live song performance. A dance troupe called Rangla Punjab, performed dances based on the folk dances of the state of Punjab. Fire 'N Ice (two women dancers) performed an Indian/American fusion dance. To round out the evening, Neeti and her husband AI, danced for the cheering crowd.

Neeti dedicated her book to Al, who was the driving force behind the publication for the book. Some of her family came all the way from India for the event: Neeti's mother, Mrs. Kiran Dewan, her mother's sister, Mrs. Vimal Sehgal, and her uncle and aunt, Mr. and Mrs. Hans Raj Sood.
